It is hereby Certified on behalf of the State Government that it is desirable and feasible to start the proposed Dental Collage at Visnagar.

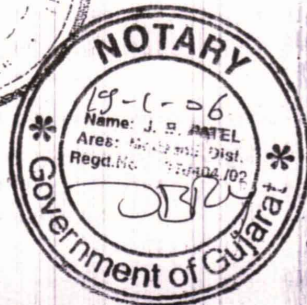

This essentially certificate is issued subject to the conditions that the College will run on fully self-financed basis and the admissions and fees will be governed by The' Justice R.J. Shah (Retired) Admission/ Fee Committee' and proposed College shall have to be affiliated with any University created under law by the State of Gujarat.

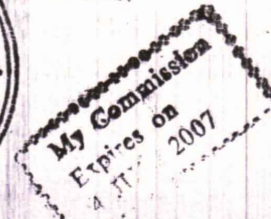
